- 3) Exterior photographs of the property/structure from all side elevations as well as interior pictures (if demolition or changes to the interior result from alterations.)
- 4) Written narrative history of the structure.
- 5) Completion of the Historic Criteria Information Table (**see below.**)
- 6) Complete written project description.
- 7) For alterations, additions, remodels, demolitions: Copies of full-size project plans (folded to no larger than 9” by 12”) and one (1) set of plans reduced to 8.5 by 11 inches
- 8) CEQA Filing Fee of \$50.00.
