Enforcement and Filing a Complaint

Signs found to be in violation of the Livermore Municipal Code may be removed and/or discarded. City staff will make every attempt to notify campaigns of improperly placed signs. Campaigns or property owners will have 24 hours to correct the signs. A citation may be issued to a campaign or property owner for improperly placed signs on private or public property.

All campaign signs shall be removed within five days after the election to which they pertain.

Complaints concerning sign violations may be reported by calling (925) 960-4444, or by visiting our website at www.cityoflivermore.net and providing the address or location of the violation along with your name, address and phone number.

All complaint information will be kept confidential.

Reference Guide to Political Campaign Signs

Information contained in this brochure is a brief summary of Livermore's sign ordinance (Livermore Development Code § 4.06.140 — Temporary Signs) and reflects our commitment to ensuring a safe community free from visual distractions and obstructions.

This reference guide is intended to provide information on the permissible location and size of political campaign signs in compliance with the Livermore Development Code.


Definitions

"Stake Signs" are mounted on a wooden or metal stick and placed in the ground:



"Public Property" is any property publicly owned outside of the public right-of-way, including parks, City Hall, the Civic Center area, libraries, Police and Fire Departments, and schools.

"Public Right-of Way" is the area within ten feet of the curb face (see drawing below):

Signs on Private Property (Greater than ten feet from curb)

Campaign signs placed on private properties must meet the following requirements:

- Maximum size of four square feet per sign
- Signs must be stake signs
- No limit to number of signs

Signs in the Public Right-of-Way (Within ten feet of the curb)

Campaign signs placed in the public right-of-way must meet the following requirements:

- Maximum size of four square feet per sign
- Signs must be stake signs
- No two signs with the same copy may be closer than fifty feet from each other
- Corner properties may have identical signs on both corners

Prohibited Sign Locations

For the safety of drivers and pedestrians, the following areas are prohibited from sign placement:

- Street Medians
- Sidewalks or Streets
- Traffic Signals
- Street Light Poles
- Power Poles
- Schools
- Parks
- Public Property

Signs placed in these areas will be removed and discarded.
